YOU ARE SPECIFICALLY REQUESTED TO PROVIDE THE ABOVE-REFERENCED DEFENDANT OR ATTORNEY OF RECORD WITH A PHOTOSTATIC COPY OF THE REVERSE SIDE OF THE CITING OFFICER'S COPY OF THE ABOVE-REFERENCED NOTICE TO APPEAR, IF THE CITING OFFICER HAS MADE ANY NOTATIONS ON IT.
  - b. The names and addresses of all prosecution witnesses who will testify at trial.
  - c. A copy of any and all documents, or other evidence, that shows that the defendant had actual knowledge that there had been a determination of noncompliance, by an independent testing laboratory, with Federal Motor Vehicle Safety Standard 218 on the item the defendant had on his head at the time you issued citation #KV50993 .
  - d. A copy of all training materials, directives, statutes, memos, bulletins, or any other publication which serve as the standard by which you determine what constitutes a helmet.
  - e. A copy of California Highway Patrol Policy relating to enforcement of Vehicle Code §27803.
